Area Updates Pennyrile Area

The Pennyrile Area has had many accomplishments since the Spring. Read on to learn how agents have made a difference in areas such as community health and wellness, food and nutrition, and COVID-19 response.

Community Health and Wellness

Nine counties in the Pennyrile Area offered a walking program that reached 159 participants. They reported 32,645,552 steps, 90% gained knowledge and skills to be physically active, 82% increased their physical activity, and 53% improved one or more health indicators.

Food and Nutrition

Early in the pandemic, grocery store shelves were bare and people relied on foods in their pantry. After a series of three classes, participants made dishes without using recipes, cooked healthier meals using pantry items; and used substitutions from the pantry.

For people with hypertension, herbs and spices can add flavor and reduce the need for salt added to foods. Participants in and Herbs and Spices class reported applying what they learned to plant, grow and use herbs for the first time.

Covid Response

The Crittenden County Extension Facebook page increased from 101 to 1221 likes and reached a total of 41,738 people. A worked together as a team to posting videos such as desert dish gardens, herb gardening, and Cook Together, Eat Together.

Caldwell County offered a slow cooker and baking challenge. Seventy Grab Bags were distributed filled with key ingredients for the recipes demonstrated. Eight recipes were demonstrated and distributed via Facebook and Youtube. 1,939 people have viewed the videos.

Area Updates Quicksand Area

Leslie County Extension FCS and 4-H Community Gardeners planted gardens with varieties of tomatoes, cucumbers, peppers, onions, squash, watermelons and more.

For some, container gardening was a better option. Leslie County FCS Extension offered a Container Gardening lesson sharing lots of educational literature along with the Farmer's Market Shopper's Guide. We explored the many pros of container gardening along with sharing our own experiences in gardening. Everyone planted their own tomatoes or peppers in a 5-gallon size fabric container interplanted with lettuce seeds and onion sets. Container gardening offers opportunity to garden on a small-scale meeting needs of those with limited space and time for traditional, large-scale gardens.

Farmers from 4-H clover bud to adult ages across Leslie County continue to practice their skills with families and community as they become gardeners! Lots of fresh farm-to-table sharing has been enjoyed across our county. Community working with Extension sustaining nutrition and educating youth and families is an ongoing part of our Extension mission.

Lee County, in Eastern Kentucky, has numerous types of wild game that can be harvested. Although a large number of wild game can be harvested, there is a lack of knowledge on how to prepare the meats, as well as, proper field to refrigerator practices.

In Lee County, the Agriculture and Family & Consumer Sciences Agents partnered together to do a two part Venison Program. The first class involved participants coming in to watch a deer be processed by Dr. Greg Renfro.

The second part of the program involved the series, titled Cook Wild Kentucky. Which features 24 recipes with some of the state's most popular wild game including venison, rabbit, fish, frog, dove, and duck. In the Cook Wild Program, the FCS Agent in Lee County prepared samples of 6 different venison recipes that participants were able to sample. Two participants tried venison for the first time. In the program agents talked about ways that you can prepare the meat without just using a "frying" method. Participants were able to take home a wide range of recipe cards.
