

A RESOLUTION supporting retaining the name - College of Home Economics.

WHEREAS, the University of Kentucky, College of Home Economics has been established successfully since 1969 and over 4,000 students have completed a degree program; and

WHEREAS, the members of the Kentucky Association of Extension Home Economist work closely with the faculty of the University of Kentucky College of Home Economics; and

WHEREAS, many of the KAEHE members are graduates of the University of Kentucky, College of Home Economics; and

WHEREAS, of the 319 United States Colleges and Universities that grant a degree in home economics, 253 are identified by the name home economics, and we do not believe an alternative name would as adequately convey our mission to the public; and

WHEREAS, the basic philosophy of home economics has not changed. It continues to be a future-oriented profession with a major focus on family well being, the growth and development of human beings, and the reciprocal relationship of human beings and families with their near environment.

NOW, THEREFORE,

Be it resolved that the Kentucky Association of Extension Home Economists go on record as of December 2, 1986 unanimously:

1. Supporting the continued use of the name of College of Home Economics for the academic unit at the University of Kentucky.
2. Urging the creation of a alumni and faculty committee to better market Home Economics and to plan for active recruitment of students.

3. Encourage the college to do research on the impact of home economics on the living skills of recent graduates and to use that research in support of the profession.

4. That copies of this resolution be sent to the Dean of the College of Home Economics, Assistant Director of Home Economics Extension and the President of the University of Kentucky.

A RESOLUTION praising University of Kentucky President David Roselle for his excellent leadership and accomplishments, and encouraging consideration of Cooperative Extension Service Staff for incentive merit increases.

WHEREAS, the County Cooperative Extension Service Agents in home economics, 4-H, and agriculture have served the citizenry of the Commonwealth of Kentucky for almost 75 years; in off campus education outreach programs of the University of Kentucky.

WHEREAS, the Cooperative Extension Service program annually reaches 5 million Kentucky families, farmers, and youth with its educational programs, seminars, and leadership development opportunities; impacting family well being and agricultural progress.

WHEREAS, the Cooperative Extension program in many Kentucky counties may be the most well-recognized professional link the public has to access national and university research information on their farms and in their homes; and

WHEREAS, forty-three percent of the Cooperative Extension Service Agents received the highest merit rating possible in the last full evaluation process, no Extension Agents were deemed eligible for merit incentives to prevent agents from feeling the financial need to leave the University of Kentucky in tough times; and

WHEREAS, lack of sufficient salary increases have prompted monetary disenchantment in Extension Educators the same as campus faculty; and

WHEREAS, the KAEHE members are very appreciative of the efforts President David Roselle has made to: increase his knowledge of the Kentucky Cooperative Extension Service, and include the Cooperative Extension Service in promotion of the total academic image of the University of Kentucky; and

WHEREAS, the KAEHE members wish to acknowledge and commend Dr. Roselle for his positive, tenacious and productive efforts with the Kentucky Legislature and the Council on Higher Education.

NOW, THEREFORE,

Be it resolved that the Kentucky Association of Extension Home Economists go on record as of December 6, 1988, unanimously:

1. Praising Dr. David Roselle for his strong leadership of the University of Kentucky and his support of the educational efforts of the Kentucky Cooperative Extension Service particularly in the area of family concerns.
2. Encouraging University of Kentucky Administration to consider top rated Cooperative Extension Service staff to receive financial incentive merit increases in future adjustments equivalent to faculty grants.
